

Artistic Policy for Leamington Art in the Park Festival

Mission Statement:

- Encourages artists to consider the environmental impact of their installations and artworks.
- Promotes the use of sustainable materials and eco-friendly practices in artistic creations.

5. **Youth Empowerment:**

- Provides a platform for emerging artists, including students and youth, to showcase their talents.
- Offers mentorship opportunities and workshops to support the development of young artistic voices.
