1. Waste Reduction:

		• Work with WDC Better points app to encourage sustainable travel.
4.	W	ater Conservation:
		• Educate festival attendees about water conservation and encourage
		responsible water use- to bring reusable water containers.
5. Biodiversity and Green Spaces:		

- Preserve and protect green spaces within and around the festival venue.
- Avoid damage to local flora and fauna and engage in conservation efforts where possible.

### 6. Education and Awareness:

- Raise awareness about environmental issues through festival programming, workshops, and signage.
- Provide information on sustainable practices and their positive impact on the environment.

# 7. Collaboration with Suppliers:

- Prioritize suppliers with strong environmental credentials and practices.
- Encourage vendors to adopt sustainable packaging and sourcing practices.
- Regularly assess and review supplier practices to ensure alignment with our environmental goals.

# 8. Continuous Improvement:

- Regularly review and update this Environmental Policy to reflect advancements in sustainable practices.
- Solicit feedback from attendees, volunteers, and stakeholders to identify areas for improvement.
- Set measurable targets and track progress toward reducing our environmental impact.

All festival organisers, staff, volunteers, performers, and vendors are expected to adhere to this Environmental Policy. Non-compliance may result in penalties or exclusion from future participation in Art in the Park.
